**ORDER:** 

In the Government Order first read above, the Government have issued orders on the procedure for admission of Diploma holders in Engineering / Technology in the second year of the 4 year B.E / B.Tech degree courses under the Lateral entry system in the year 1994-95.

2. The Principal Secretary / Commissioner of Technical Education in his letter fifth read above, has stated that various norms adopted for admission to second year B.E/B.Tech degree courses through the Lateral entry system including Nativity rules, Eligibility rules, Special reservation, Selection procedure, Conduct of counselling were issued from time to time through Government orders second, third and fourth read above. He has further stated that the revision in certain norms adopted for admission to Lateral Entry B.E/B.Tech degree courses has become necessary from the year 2015-16 onwards. The revision is proposed to maintain State norms concurrent with AICTE norms. He has also listed out the existing norms and revision proposed as follows:-

The Principal Secretary/Commissioner of Technical Education has sent Revised Guidelines for admission to Second Year B.E/B.Tech Degree Courses through Lateral Entry in the Colleges affiliated to Anna University from the year 2015-16 onwards and requested Government orders. The Registrar, Anna University in his letter sixth read above has also agreed to the revised norms proposed by The Principal Secretary/Commissioner of Technical Education.

3. The Government after careful examination have decided to accept the proposal of the Principal Secretary/Commissioner of Technical Education. Accordingly, the Government approve the guidelines for admission to Second Year B.E/B.Tech Degree Courses through Lateral Entry in the Colleges Affiliated to Anna University from the year 2015-16 onwards annexed to this Government order.

#### ANNEXURE

## (G.O.Ms.No.74, Higher Education (J1) department dated 20.4.2015)

Revised norms to be adopted for admission to Second year B.E / B.Tech degree courses through Lateral Entry from the academic year 2015-16 onwards:

## (1) B.Sc students – Mathematics subject of study

B.Sc candidates who have taken Mathematics at +2 level or studied Mathematics as core or ancillary subjects at B.Sc level alone are eligible for admission to B.E / B.Tech degree courses through Lateral Entry.

# (2) Qualifying examination marks to be considered for calculation of minimum eligibility marks

Qualifying examination marks to be considered for calculation of minimum eligibility marks as prescribed in G.O.(Ms)No.263, (J2) Department, dated 30.6.2008 (in respect of Diploma candidates) and G.O.(Ms)No.154, Higher Education (J1) Department, dated 4.6.2007 (in respect of B.Sc candidates) shall stand modified as follows:-

# (3) Qualifying examination marks to be considered for selection and preparation of merit list:

Qualifying examination marks to be considered for selection and preparation of merit list as prescribed in G.O.(Ms)No.364, Education, Science and Technology Department, dated 10.5.1995 (in respect of Diploma candidates) and G.O.(Ms)No.154, Higher Education (J1) Department, dated 4.6.2007 (in respect of B.Sc candidates) shall stand modified as follows:-

### (3) Conduct of Counselling

AICTE in its Approval Process Hand Book 2013-2014 has stipulated that the students belonging to B.Sc stream shall be considered **only** after filling the supernumerary seats (20%) in Lateral entry category with students belonging to the Diploma stream. Accordingly, the counselling shall be conducted first for Diploma stream students against Government quota seats for Lateral entry. Unfilled seats, if any at the end of counselling for Diploma candidates shall be filled with B.Sc candidates. In respect of all other norms for eligibility, special reservation and communal reservation for admission to Second year B.E / B.Tech degree courses through Lateral entry, already existing norms shall be adopted.
